Important Questions	Answers	Why This Matters:
What is the overall deductible?	\$4,600 member / \$9,200 family	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your deductible?	Yes. Certain <u>preventive services</u> , office visits, tests and prescription drugs are covered before you meet your <u>deductible</u> . See the specific services listed below denoted ' <u>Deductible</u> does not apply'.	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. Does this plan provide Minimum Essential Coverage? Yes
